# Driver Registration

## DRIVER REGISTRATION - [DEADLINE: MARCH 20, 2026](#)

**Step One:** [Register Online](#)

**Step Two:** Email all supporting registration forms and documents to [TDC@watrucking.org](mailto:TDC@watrucking.org). The required supporting forms and documents must be submitted to WTA by the close of business on March 27, 2026. These forms and documents include the following: (1) 2026 ATA Driver Entry and Release Form (11-12 pg.); (2) Current Motor Vehicle Record (MVR); (3) CDL/driver's license with proper endorsements; and (4) driver photo.

All designated primary and additional company contacts will receive a confirmation email after the entry deadline with drivers' names and classes; please verify that all information in this email is correct and confirm with [TDC@watrucking.org](mailto:TDC@watrucking.org).

Registration is capped at 200 registered attendees.

## COMPLETING DRIVER REGISTRATION:

- All competitors and officials must register using WTA's online registration and submit additional forms and documents.
- Current MVR – Must be pulled within six months of August 11, 2026 (February 11, 2026) and show that the driver's medical certificate is valid on the MVR (if required).
- CDL copy – The driver must have the proper endorsements for the class entered. Competitors in the Straight Truck must have a minimum of a Class B License.
- If a driver's CDL or medical card expires by April 1, 2026, a new license or medical card must be provided by April 1, 2026, before they are eligible to compete.
- The employer of the 2026 WATDC Division Winners must be a member of the Washington Trucking Associations (WTA) and provide the National Truck Driving Championship (NTDC) Entry Fee to be eligible for Nationals. Credit card fees will apply.
  - WTA member companies will be invoiced NTDC entry fee(s) for submitted competitors. Non-member companies will be invoiced NTDC entry fee(s) and WTA membership dues.
  - All invoices must be paid by [June 1, 2026](#), for NTDC entry.
  - All 2026 WATDC division winners, with one guest, are invited to the 2026 Day with the Winners event on Saturday, August 22, 2026, at the Tacoma Country & Golf Club in Lakewood, Washington. *RSVPs required.*

If a driver's CDL or medical certificate expires by April 1, 2026 a new license or medical card must be provided by April 1, 2026 before they are eligible to compete.

No class or driver changes will be accepted after April 3, 2026, including onsite.

### **COMPETING DRIVERS MUST:**

- Be based or licensed in Washington and in a driving position with their current employer since August 11, 2025.
- Perform a minimum of 1,200 hours annually as a professional truck driver.
- Have the proper license endorsement for the class of participation chosen.
- Have had an accident-free driving record since August 11, 2025.
  - Drivers with non-preventable crashes may be eligible to compete.
    - Documentation must be submitted to the WATDC Planning Committee by April 1, 2026, for all non-preventable crashes (including non-DOT recordable) for review.
- Have not been away from the regular driving duties beyond an aggregate of 30 calendar days since August 11, 2025.
- Drivers are prohibited from receiving any form of compensation for time spent in practice.
- Companies may reimburse drivers for expenses incurred in attending the competition, but such reimbursement is limited to the actual expenses for the participant and spouse.

# Event Information

## DEADLINES & PUNCTUALITY

All participating companies, managers, and drivers must meet the required deadlines and be prompt for all events. Failure to meet deadlines and/or tardiness may result in disqualification. The deadline for emailing all forms and documents is [April 1, 2026](#).

## DRIVER CHECK-IN

Driver check-in will be on Saturday between 6:00 AM – 6:40 AM at the HAPO Center (6600 Burden Blvd, Pasco, WA 99301). All competitors **MUST** present a valid CDL or driver's license with proper endorsements.

All drivers will receive a name badge at registration. Drivers **MUST** wear it at all times during the competition.

## WELCOME & INTRODUCTIONS

All drivers **MUST** be present for the welcome and introduction starting at 6:45 AM. Drivers not present at the start of the welcome and introductions will not be eligible to compete.

## WRITTEN TEST

Saturday at 7:00 AM – 8:00 AM.

Drivers do not need to bring anything for the written test and should not sit next to other competitors from their company. A designated area for backpacks and other items will be available, but will not be accessible between 6:45 am and the walk over to Gesa Stadium. Cell phones, smartwatches, digital watches, or other prohibited devices must be turned off, placed in bags, and located in the designated area.

## TDC OVERVIEW & COURSE WALK

Immediately following the written test, there will be a presentation to review the TDC rules and guidelines, skills course problems, and pre-trip inspection information.

The skills course walk will commence at 9:10 AM. The course walk will be no more than 10 minutes, and drivers may not ask questions during the course walk. Drivers may not pace the course or measure the distance between problems or equipment. The use or possession of phones, smart watches, or pedometers is strictly prohibited and will result in disqualification.

# Event Information

## DEN MOTHERS/ FATHERS & BULLPENS

All drivers will be assigned a holding group and a Den Mother/Father will be assigned to the holding group immediately following the skills course and pre-trip instructions overview presentation. The assigned Den Mother/Father will be the holding group's "tour guide" between the skills course and the pre-trip inspection areas.

Drivers are required to follow Den Mother/Father instructions and report to the driver staging area promptly after the announcement to report. Once in the driver staging area, and checked in, the Den Mothers/Fathers will then bring the holding groups to their assigned skills course or pre-trip bullpens.

## ELECTRONIC DEVICES

Cell phones, cameras, recording devices, and devices that can receive data, send data, and/or signal notifications, or the use of any form of AI, are prohibited during any phase of the competition. Failure to comply will result in immediate disqualification.

Once a contestant has completed the written test, skills course, and pre-trip inspection, the use of the listed devices above is allowed.

## FREE PERIODS & DRIVER DISCUSSION

Drivers are allowed to watch the competition during free periods, but drivers are expected to report to the driver staging areas promptly after the call to report.

Any contestant not in the assigned bullpen with their holding group may be subject to disqualification.

Discussion of the skills course or pre-trip details with other drivers is strictly prohibited until all drivers have completed the event activities.

## APPEARANCE OF DRIVERS

Competitors should be in company identifying clothing and wear the name badge provided during check-in.

# Event Information

## CODE OF CONDUCT

Participation in all WATDC-hosted events is subject to the observance of the WTA's rules and procedures. The activities outlined below are strictly prohibited. Any participant, volunteer, or staff member who violates this Code is subject to removal from the 2026 WATDC activities and possible future WTA-hosted events.

- Abusive language towards a staff member, volunteer, or another participant.
- Possession or use of alcoholic beverages or illegal drugs within the HAPO Center and GESA stadium's parking during WATDC activities.
- Bringing dangerous or unauthorized materials such as explosives, firearms, weapons, or other similar items onto event property.
- Discourtesy or rudeness to a fellow participant, staff member, or volunteer.
- Verbal, physical, or visual harassment of another participant, staff member, or volunteer.
- Actual or threatened violence toward any individual or group.
- Conduct that endangers the life, safety, health, or well-being of others.
- Failure to follow any agency policy or procedure.
- Bullying or taking unfair advantage of any participant.
- Failing to cooperate with WATDC leaders or WTA staff.

## DRIVER MANAGER/ TRAINER COMPETITION

The Driver Manager/Trainer Competition is a SKILLS COURSE ONLY competition for driver trainers and supervisors with a valid Class A CDL. Government agency partners with Class A CDLs may also be eligible to compete. All competitors must be registered by Friday, March 20, 2026, with proof of Class A CDL and the Driver Manager/Trainer event consent form (page 14).

Competitor check-in will be from 6:00 am to 6:40 am at the HAPO Center and 9:00 am – 2:00 pm at the event information tent for the name badge and course information. All competitors may attend the WATDC overview briefing following the discussion of the written test (estimated 8:00 am). However, all competitors are prohibited from attending the course walk at 9:10 am. There will be a five-minute course walk prior to the start of the event. All competitors must be in the designated bullpen before the first competitor enters the course.

Competitors may participate as volunteers, including skills course judges, but are prohibited from being involved in Friday Skill Course setup or driving the 2026 Skill Course prior to the event.
